## **Maryland County Health Regulations**

Related to Farm Products Sales at Farmers' Markets and Farm Stands and to On-Farm Processing

County health departments are responsible for certain aspects of food sales. Information on the following pages outlines key county data related to sales on farms and at farmers' markets. The information was provided primarily by county health departments in response to a survey complied by the Maryland Department of Agriculture (MDA) in 2005. Data is still pending from some counties, and will be added when available. For additional information, contact your county health department. Most Maryland counties and the City of Baltimore allow the sale at farmers' markets and farm stands of fresh farm produce, herbs, cut flowers and bedding plants without additional licensing. Most counties also allow the sale of certain baked goods, jams and jellies, as outlined in DHMH Farmers' Market Memo 80-6 dated 08-27-92 & Supplement dated 11-07-01. Some counties allow additional products and/or require additional permits or licenses as shown. Individual Farmers' Market Managers may also have additional requirements for particular markets.
